9:00am CALL TO ORDER

9:05am APPROVAL OF OCTOBER MINUTES

Motion to approve the October OSRAC meeting minutes by Foulis second by Owners. Motion passes unanimously.

9:10am DISCUSSION

9:10am (20 min) Haymaker winter use follow-up

- It is too close to the 2021 closure date to consider changing any winter management of trails this year.
- The Committee elected to support approaches to educate users on best practices while recreating during the winter. This included supporting VVMTA's Wildlife Trail Ambassador program and exploring existing and new approaches to encourage responsible recreation in the winter.
- The topic will continue to be discussed throughout the winter.

Motion to amend the motion to Town Council from the October 5 OSRAC meeting by Saeger second by Foulis. Motion passes unanimously.

Motion for OSRAC to continue researching the topic of future closures of the Haymaker Trail area while implementing action items this fall and winter to include education, information gathering, enforcement, and additional signage completed by Town staff and community partners by Hoban second by Foulis. Motion passes unanimously.

9:30am (20 min) Town of Eagle e-bikes

- The Town of Eagle is evaluating existing policies for e-bikes on paved trails, roads, rights-of-ways, and soft-surface paths. A public Town Council Work session was held on October 5 to discuss e-bikes.
- OSRAC will likely be engaged to provide thoughts and comments as this continues to evolve.

9:50am (10 min) Open Space and Trails Master Plan Open House follow-up

- Approximately 50-60 people attended the first Open Space and Trails Master Plan open house on October 19. Attendees provided feedback about the open space program and the direction for the program for the next ten years.
- There is a survey posted online at the project website that people can fill out to provide feedback for those who could not make it to the open house. The survey is available through November 10, 2021.
- After the survey closes, the project consultants will begin to provide results.
- Two more focus groups are scheduled for early December and a final open house for January 2022.
- The master plan should be complete in February 2022.

10:00am (25 min) 2022 Proposed Budget (Open Space and River Park)

- Committee members expressed support for a PFD rental station and additional throw bags at the river park.
- Committee members expressed support for additional trailhead kiosks and wayfinding signage in Spanish for open space and the river park.
